

Dear Community Members—

Repeated often during the 2020-2021 school year were the words, "flexibility, compassion, and grace." For an unprecedented time in public education, this motto guided us to a Safe Start and a Strong Finish as we navigated the reopening of schools during a global pandemic. Through it all, we remained committed to providing a safe and healthy school environment and enriching educational pathways.

When the 2020-2021 school year began, LCS offered three education options: in-person learning, school-based Digital Academies, and Leon County Virtual School. In order to best equip our scholars for both the present circumstances at-hand, and for the future, we made the financial commitment to purchase Chromebooks for all of our students. In addition, our schools adopted Canvas, a Learning Management System (LMS). Our teachers adapted to not only Canvas, but also a hybrid educational model as they taught both in-person and Digital Academy students. There aren't enough words to thank our teachers and support staff for their fortitude and commitment to keep everyone safe and continue to provide daily instruction.

Along with classroom and at-home learning, we also served and delivered over a million meals both in school, drive-thru pick-up, and select school bus stop deliveries. Because we realized mental and emotional health support services would be even more vital during this time, we were able to provide virtual counseling services to our Digital Academy students. With safe planning, abbreviated sports seasons and extracurricular activities resumed; parents and families transported their student for after-school activities and mandatory tests; and the Class of 2021 was able to celebrate with alternative prom events and outdoor graduation ceremonies at Gene Cox Stadium.

Although the 2020-2021 school year had never-before-seen challenges, we firmly believe that as a school district family, we rose up together to meet them. We are proud of our efforts to keep students safe and our schools open. The 2020-2021 Annual Report reflects our mission and vision in continuing to provide a world-class education to our Leon County school students through a Safe Start and a Strong Finish to the academic year.



Integrity & Ethical Responsibility. LCS requires the highest level of integrity and personal responsibility for all stakeholders.


Equity. LCS fosters an environment that encourages all stakeholders to close the achievement gap, maximize achievement for every learner and provide equitable opportunities for all.

We equip them with the skills necessary for future success—whether it is post-secondary education pursuits or workforce development. Leon County Schools endeavors to deliver innovative, advanced, and relevant academic curriculum, along with real-world opportunities that are responsive to labor market trends, align with a student's goals and diverse needs, and prepares them to excel in their chosen profession or vocation.

Our goal is to promote the value and benefits of taxpayer investment in Leon County Schools, along with implementing a culture of continuous improvement, reducing debt and energy waste, encouraging sustainability practices, and optimizing efficiency and effectiveness.





Safe Schools and Work Environments

COVID-19 Protocols and Response

- Created a Reopen Leon Schools plan, and a health and safety procedures manual to provide a safe, secure, and clean environment for all students, employees, and visitors.
- Created a COVID-19 Dashboard to track cases among students and employees.
- Hired additional custodial staff to clean and disinfect schools and facilities; established "The Strike Team."
- Created a diverse Re-Open Leon Schools Task Force committee to provide guidance, and field questions from parents, students, staff, and community members.
- Transportation made adjustments to accommodate students on buses, including seating charts and keeping two students per seat to assist with contact tracing. Conducted additional cleaning and disinfection procedures between runs.
- Shipped Personal Protective
 Equipment and supplies to schools
 and administrative sites, including:
 - *Gloves: 893,300 Units
 - *Disposable Masks: 10,500
 - *Reusable Masks: 3 million cloth and 5,000 H600 surgical grade masks
 - *Face Shields: 5,000
 - *Hand Sanitizer: 7,568 bottles
 - *Digital Thermometers: 2,342
 - *Disposable Gowns: 2,000



Established a Safe Start brand and website to share the Reopening guide / resources and information, along with the academic plan, which included the Digital Academy option for school sites.

- Promoted testing and vaccination events, along with providing testing sites and vaccination collaboration with the Leon County Health Department and other partners.
- We provided more than 1.9 million meals (regular menu in schools and at curbside meal distributions).

Department of Safety and Security

- Completed assessments of all of our facilities as required by the Marjory Stoneman Douglass Act.
- Developed a School Guardian program to supplement our longstanding School Resource Deputy Program.
- Made numerous enhancements on school campuses with upgraded security cameras, security fencing, security stations, emergency mass notification systems, security window tinting, access control.
- District Security Center—marketing enhancements.



3 million cloth and 5,000 H600 surgical grade masks distributed

- Implemented school safety analyst positions: they help with social media monitoring related to threats to our schools, student /individual self-harm.
- Collaboration with the Professional and Community Services Department to implement enhanced security for school board meetings.
- Implemented districtwide mobile RAVE Panic Button.

Social / Emotional Well-Being and Mental Health

392 Newly trained school level staff in Youth Mental Health First Aid (YMHFA). YMHFA is an evidence-based youth mental health awareness and assistance training program to help school personnel identify and understand the signs of emotional disturbance, mental illness and substance use disorders, and provide such personnel with the skills to help a person who is developing or experiencing an emotional disturbance, mental health or substance use problem.



The COVID **Health Heroes** campaign was created in collaboration with Sachs MEDIA, who generously donated their time and services. The campaign included designs for posters and social media



graphics and videos that featured a diverse group of students who illustrated how to be a "COVID Health Hero." Our thanks also to the community partners (Sigma Gamma Rho Sorority, 100 Black Men, and the Rotary Club of Tallahassee Southside) who funded the printing of the posters that were displayed at all of our school sites.

Direct employment of ten (10) LCS school-based mental health services providers — school psychologists, school social workers, and school counselors.

- 271 Instructional Staff completed social and emotional learning (SEL) professional development receiving instruction on topics of SEL curriculum concepts, strategies and implementation options; practice in facilitating studentdriven discussions and engagement strategies; and links to academic motivation and skills.
- Each school's crisis response team completed training on the Threat and Suicide Risk Assessment process.
- Contracted Services with community-based partners (DISC Village, Inc.) to provide ten (10) specialists to implement evidence based mental health programs and provide support to elementary schools.
- Interagency agreement with DISC Village, Inc. to add 3 mental health counselors and 17 Health and Wellness Special to focus on delivering evidence-based mental health care treatment to students in secondary schools.

- Interagency agreements and collaborative efforts or partnerships with community mental health programs, agencies, or providers to provide additional mental health, social/emotional behavior, and substance abuse support upon parent initiation or school referrals.

Per the Florida Department of Education, due to COVID-19, school grades were not given out to all districts unless requested.

- Chromebooks and Internet Access
 - Provided a Chromebook (1:1) for every Leon County Schools student.
 - Through the Foundation for Leon County Schools Internet for All campaign, Comcast Internet Essentials and hotspots were provided to any family in need of Internet connectivity.
- Implemented Canvas, a Learning Management System (LMS) districtwide.
- Partnered with the nation's online learning leader—Florida Virtual School, for digital content.
- More than 64,000 progress monitoring assessments were administered.
- Expanded intervention services for in-person and at-home learning.
- Provided virtual mentoring and volunteering opportunities.
- Amos P. Godby High School and James S. Rickards High School continue to offer Advancement Via Individual Determination (AVID) programs.

Preparing Students for College and Career

- Ensuring that all students graduate with a relevant, viable, postsecondary plan.
 - All of our high schools offer Honors, Advanced Placement, and dual enrollment classes.
 - All of our middle schools offer high school credit classes.

- All of our schools offer Career Technical Education (CTE) opportunities.
- Fifteen graduating seniors earned their associate degree (AA) from Tallahassee Community College (TCC), along with their diploma.

- Increased kindergarten readiness for students attending an LCS Pre-K program.



- Provided specialized instruction through the Canvas platform as well as through other encrypted, remote means such as MS Teams and Zoom in addition to curricular packets that were made available to parents.
- Continued to track student progress in order to develop robust IEPs.
- All ESE instructional and related services providers collaborated to schedule and provide remote services.
- Finalized all components of open evaluations and re-evaluations that could be completed remotely.
- Utilized national and state-wide resources in order to support students with disabilities.
- District ESE administration participated in regularly scheduled statewide information sessions in order to build capacity in providing services to students with disabilities during COVID-19.

- Ensured student confidentiality during remote learning activities by having parents adhere to FERPA guidelines for the provision of remote, group instructional services.
- Offered parents resources in how to assist in their child's learning during school closures.
- Held routine remote training/ information sessions for all ESE support personnel in how to effectively support school-based and itinerant ESE personnel in providing effective and feasible services to their students with disabilities.
- Provided robust Talented and Gifted Services for our Schools.

- Continued to provide a districtwide graduation coach.
- Continued to provide programs to meet unique academic and behavioral needs of students in special circumstances such as Ghazvini Learning Center, Success Academy, Heritage Trails, PACE Center for Girls, and SAIL High School.
- Continued to provide a variety of programs for adult learners to be successful in a changing economy through Adult and Community Education (ACE) and Lively Technical College.
- Continued to provide year-round access to Leon County Virtual School to all Leon County Virtual School students. The Leon County Virtual School franchise was ranked #1 in the state of Florida for the 2020-2021 school year.

Fiscal Stewardship and Transparency

- Set up Fiscal Transparency website with links by school showing three years of expenditure and staffing trends.
- Implemented cash management changes that increased interest earnings by 89% (pre-COVID-19) (Interest earnings previously \$160K/ pre-covid \$1.5M).
- Implemented electronic vendor payment process resulting in savings in postage and paper check utilization.
- Continuing to review and evaluate current processes and procedures to decrease audit criticism. Recently moved p-card reconciliation online to eliminate deficit spending and improve accuracy.

- Maintained AA Bond Rating from Fitch Ratings through pandemic while other Florida school district ratings were decreased. Fitch specifically referenced our district's increased financial resiliency and gradual increase of general fund unrestricted balance since last evaluated in 2016.
- The District has paid off 31% (\$70,867,895) of its debt; the District's beginning debt balance on July 1, 2016 was \$225,205,186 and as of June 30, 2020, at the height of the COVID-19 Pandemic, the ending debt balance was \$154,337,891.
- Received clean audit of Annual Financial Reports from the Auditor General's Office for two concurrent three-year cycles.



- Initiatives from FY 2018-19 continued in FY 2019-20 and FY 2020-21.
- Continued pay raises for all employees from the prior year \$8.6M.
