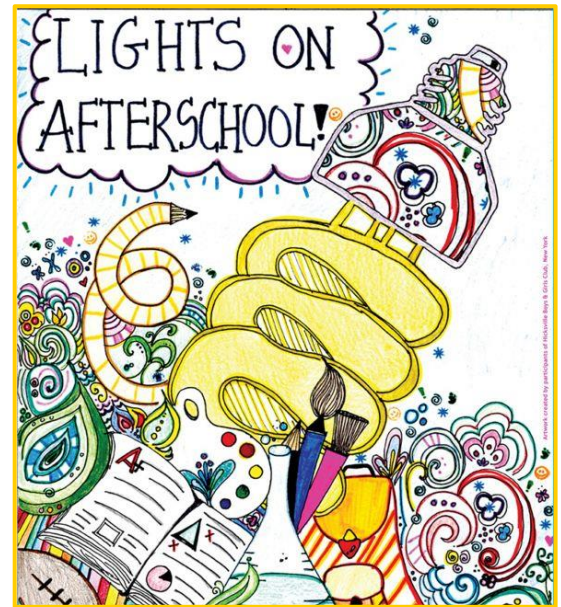
Please know that our programs could not be successful without each of you! We look forward to an amazing year and hope that you enjoy Soaring Beyond Expectations!

"We are excited to have the program here at Nims Middle School. We take honor in providing our students with an array of services that complement the regular academic rigor in the classroom and tons of enrichment."

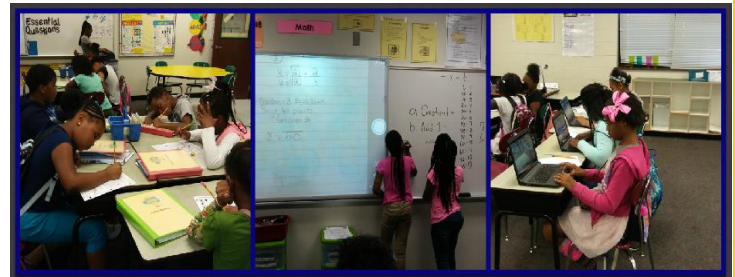

Compliance Corner!

Staying in compliance means that each site is doing what is required in order to keep the 21st Century grant. An important part of being compliant is making sure deliverables are accurately turned in on time. Deliverables are the necessary documents needed to show evidence that the program is running properly. There are several statutory and regulatory requirements that sites must adhere to in order to run a successful and safe program.

The Florida Department of Education, 21st Century Program provides a list of documents that are needed each month. While FDOE may have decreased the number of deliverable items they collect during the month, we are still expected to maintain these items on file and provide such documents during their onsite monitoring visits. The 21st Century district team will assist your site in ensuring that FDOE receives these items on time.

Leon County Schools and The Boys & Girls Club of the Big Bend (BGCBB) have worked together to bring academic achievement and character development to the students of Leon County for many years.
