ACTION REQUESTED: The Superintendent recommends approval of the recommendation to award and purchase order to Great Southern Demolition, Inc., the prequalified, responsible and responsive bidder meeting all requirements, and who submitted the lowest bid in the amount of \$219,100.00.

ITEM SUMMARY: The Facilities and Construction Department issued an Invitation to Bid (ITB) 5692-2023 for Demolition and Abatement of Old SAIL Buildings 1, 2, 3, 4 and 5 and Portable 99-408 Project. Three (3) Contractors submitted bids in response to the above referenced Invitation to Bid. It is recommended that Bid 5692-2023 Demolition and Abatement of Old SAIL Buildings 1, 2, 3, 4 and 5 and Portable 99-408 Project be awarded to the prequalified, responsible and responsive bidder meeting all requirements, Great Southern Demolition, Inc., in the amount of \$219,100.00.

Great Southern Demolition, Inc is a prequalified vendor with Leon County Schools and has met all pre-qualification requirements, including minimum insurance coverage. The District’s Contract Manager maintains proof of required insurance as part of the Contract Management file. Additionally, Contractors are required to provide proof of insurance before the issuance of permits.

The recommended construction delivery method for this project is Bid. The scope of work is defined demolition and abatement of Old SAIL Buildings 1, 2, 3, 4 and 5 and Portable 99-408. District staffing is sufficient to provide the type of supervision needed on this project and has recent experience with demolition projects. Costs will be monitored to ensure we stay within budget.

Great Southern Demolition, Inc. has earned an estimated amount of \$0.00 of projects over the past three (3) years.
