**ACTION REQUESTED:** The Superintendent recommends Board approval of the award of RFQ 511-2023 for Griffin Middle School, New Classroom Building, New Gymnasium with Locker Rooms and Stage, Demolition of Existing Gymnasium, Demolition of Buildings 2, 4, and Part of 9, Demolition of Existing Stage in Dining Area to Expand Dining Area, Add Additional Parking, Enlarge Holding Pond and Site Work Project to Architects Lewis+Whitlock, PA as the highest ranked firm, in accordance with Section 287.055, Florida Statutes, and authorizes the District to move forward in negotiations to finalize a contract. Should negotiations fail with Architects Lewis+Whitlock, PA, approval of this agenda item authorizes the District to negotiate with the next-highest-ranked firm. Once negotiations have been finalized, the contract will be submitted to the Board for approval.

ITEM SUMMARY: The Selection Committee for RFQ 511-2023, conducted interviews of responsive firms on May 12, 2023, for the Griffin Middle School, New Classroom Building, New Gymnasium with Locker Rooms and Stage, Demolition of Existing Gymnasium, Demolition of Buildings 2, 4, and Part of 9, Demolition of Existing Stage in Dining Area to Expand Dining Area, Add Additional Parking, Enlarge Holding Pond and Site Work Project. Eight (8) firms submitted qualification statements for this project, of which five (5) were selected to interview. The committee ranked the firms as follows:

- 1. Architects Lewis+Whitlock, PA
- Fitzgerald Collaborative Group, LLC tie MLD Architects, LLC - tie
- 3. Hoy+Stark Architects, P.A.
- 4. Altman+Barrett Architects, PC

The total estimated construction budget for this Project is \$7,425,000.

The recommended construction delivery method for this project is Construction Management. Major tasks are defined, but there is potential for unknown conditions and the need to work around the school's schedule. The type of work is not unique, but the required trades' coordination and timing are complicated. District staffing is insufficient to provide the type of supervision needed on this project during the busy summer construction session.

Architects Lewis+Whitlock, PA, has earned \$14,640 from Leon County School Board projects over the last 3 years.

This will be a phased project.
