Section 4.27 (e): Access to Records (2 CFR Part 200.336): All vendors, contractors and subcontractors shall give access to the School Board of ~~Polk~~ **Leon** County, the appropriate Federal agency, Inspectors General, the Comptroller General of the United States, or any of their duly authorized representatives to any books, documents, papers and records of the vendor which is directly pertinent to this specific bid for the purpose of protest within the time prescribed in Section 120.57(3), Florida Statutes, or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes.making audit, examination, excerpts and transcripts.
