- IV. **Welcome from School Board Member Laurie Cox:** Appreciative of DAC members for coming on week nights to meet. She would like DAC members to continue to update the Board in regards to questions or concerns from DAC or SAC.
- V. **Approval of Agenda:** Motion made by Damaris Barrios and seconded by Shayla Cole
- VI. **Approval of Minutes:** Motion by Shayla Cole and seconded by Damaris Barrios
- VII. **SDAC:** Students were attending to school obligations. Notes were relayed by Joe Burgess. The students were invited to John Hunkiar Security Center. They had lunch and were given

updates about Safety and Security along with new programs and initiatives happening at the schools.

- VIII. Florida Prepaid:** Florida currently has the longest running plan for prepaid tuitions. If enrolling now the prices for college are for the current prices we pay now. Prepaid is inflation proof. Open enrollment is Feb. 1 – April 30. Prepaid can be used nationwide and can be used at technical schools as well. If a child receives a full scholarship they you will get a full refund.
- IX. SESIR Updates:** The effective date for the new rule was 1/17/23. Schools are required to report all SESIR data to DOE monthly. \*\*Student data does not go to DOE with the data.
- X. R. Frank Nims Uniforms:** The start of wearing uniforms started out as a safety concern. For example, M.S. Douglas tragedy had a student enter the school and he blended in. If students been wearing a uniform the assailant would have stood out in the crowd. Also, uniforms put everyone at the same level and students aren't bullied based on their clothing. This has been a 2.5-year process to get the uniforms. The process started off with community conversations, surveys, buy in with staff, and buy in with the students. If students don't have uniforms then the school has donors to help out those students. Additionally, the Principal spoke to stores in the community that sell uniforms and asked them to order uniforms in bulk.
- XI. Policies:** 7410 – maintenance. There was a correction and update. They changed the verbiage from prevention to preservation. Motion made by Johnitta Wells and seconded by Scott Whittle. It was approved unanimously. 8600 – transportation. Revisions and language changes. There is a statute that have a 2-mile walking range for elementary students. Motion was made by Scott Whittle and seconded by Keith Berry. It was approved unanimously. 8600.04 – Bus Operator Qualifications. CPR and safety trainings every 2 years. with recertification Motion was made by Scott Cole and seconded by Shayla Cole. It was approved unanimously. 2431 – Interscholastic Athletics. A student from private school can participate in public school activities but, they have to meet all of the same qualifications that public-school students have. Motion was made by Keith Berry and seconded by Johnitta Wells. It was approved unanimously. 8452 – Automated External Defibrillators (AED). All school are required to have at least one on campus. Motion was made by Shayla Cole and seconded by Latanya Peterson. It was approved unanimously.

- XIII. SAC Questions:** It was asked if the district has any connections with colleges/universities with legislation. It was brought up that school starting later for high school students and sleep deprivation. It was questioned how the district handle school start times if passed.

#### 2440 - ~~SUMMER PROGRAMS~~~~SCHOOL~~

~~The School Board may conduct a summer program of academic instruction for students in grades kindergarten through twelfth (12th) grade remediation and those Exceptional Student Education (ESE) students needing extended school year service, as identified in their Individual Education Plan (IEP), for resident students of this District, and other students as approved. In addition to the kindergarten through twelfth (12th) grade remedial and exceptional student education summer program, the District may choose to implement summer enhancement programs for students in grades pre-kindergarten through twelfth (12th) grade, contingent upon Board approval.~~

~~In accordance with State law, the Board will operate the mandatory summer voluntary pre-kindergarten program, and the Department of Juvenile Justice educational programs.~~

The School Board shall provide summer programs for students including, but not necessarily limited to, the following:

- A. ESE Students needing extended school year services ("ESY") as identified in their Individual Education Plans ("IEP"). Summer ESY programs for each individual ESE student shall be provided in accordance with the student's IEP. Students in third grade who have not achieved the standards required for promotion shall also be eligible for summer programs.
- B. Summer programs for third grade students retained under the provisions of F.S. 1008.25(5)(b) shall include a summer reading camp. Additionally, summer programs for third grade students shall provide required reading remediation and opportunity to demonstrate reading proficiency.
- C. In accordance with State law, the Board shall administer the voluntary prekindergarten education program at the District level for students enrolled under F.S. 1002.53(3)(b) in a public school summer prekindergarten program.

The District may choose to implement summer programs for students, contingent upon Board approval, to provide:

- A. Academic instruction for students in grades K-12 remediation in Math, English, Science, and Social Studies for resident students of the District and other students.
- B. Enrichment programs.
- C. Credit recovery.

#### Transportation

~~With regard to transportation,~~ the Board shall be responsible for transporting ESE students in accordance with the terms of students' IEPs. The Board shall also transport Grade 3 summer camp students.

The Superintendent shall be responsible for developing administrative procedures for the operation of summer programs which shall be consistent with Board policies and not conflict in any way with the administration of the regular school sessions of the District.
