- IV. Welcome from Superintendent Hanna: We are keeping track of legislative outcomes. Mr. Hanna will be meeting with lobbyist for updates and planning on 4/7/23. There are still concerns for graduation rates because this is the group of students that missed in-school due to COVID. There are programs that are starting to recruit and retain teachers and non-instructional staff. They are meeting with college students (interns) to teach. They are also speaking to high school students about becoming teachers. Representative Simon still has not responded to requests for a meeting with the superintendent.

- VI. Approval of Minutes: motion by Keith Berry and seconded by Damaris Barrios. Motion approved.

- VII. SDAC: Amaya informed us that students met with Safety and Security and was able to go back to their respective schools and give information to their administration.
- VIII. Office of admissions: next years enrollment has begun. So far there are about 600 students that have enrolled for prek and about 100-150 have enrolled for Kindergarten. Kindergarten enrollment is open all summer. Reminder that all families need to make sure they do a change of address if they have moved. Also, 5th and 8th graders HAVE to verify addresses.
- IX. Policy: Policy 2440 is changing summer school to summer programs. Transportation during summer is offered to ESY and Summer Reading. Motion made by Cheryl Collier Brown and seconded by Gillian Gregory. Motion passed unanimously.
- X. Lively: Lively offers CTE with dual enrollment. There are currently 292 high school students that are utilizing dual enrollment. There are 17 CTE career clusters that range from Agriculture to Transportation. When students are dual enrolled with Lively they are considered AP courses. Schools do receive federal dollars for student certifications. There are currently 42 Seniors graduating with CNA certification and the pinning ceremony will be on 4/12/23.
- XI. Questions /concerns from last month: There were concerns about the human growth curriculum. This curriculum is what the school board votes on and is not brought to DAC. However, there is an open forum for all stakeholders to get clarification. The curriculum can also be found on the district websites. There was also a concern about what happens to the student's whose parents opt out of having them participate. The students will then have alternative assessments, be exempted out from the teacher, and they will be move to the library or to another class.
