

Interim Committee Weeks

- ► Lawmakers' first time in Tallahassee since last session
- Scheduled between regular legislative sessions
- ► Lay the groundwork for the next legislative session
- Allow lawmakers to deliberate on important issues, study proposed legislation, and prepare for the upcoming session

Committee Hearings

- ► The heart of the legislative process
- Where proposed bills are debated, amended, and ultimately voted upon.
- Offer opportunities for public scrutiny, expert testimony, amendments and refinement, party and constituency considerations, and vote and advancement.

Long Range Financial Outlook



The LRFO focuses on General Revenue (GR), which is the largest source of state revenue used to fund K-12 public education providers



The LRFO also assumes the continuation of the current policy of allowing the current Required Local Effort (RLE) millage to be applied against the new school taxable value in each district and that the Legislature will not apply the rolled back rate that would reduce the millage rate to prevent RLE revenue to increase as a function of market forces increasing School Taxable Value.



The LRFO projects the "critical" and "other high priority needs" for the FEFP. Workload and Enrollment in the FEFP is the "critical" FEFP need.



The Outlook forecasts an increase in enrollment in the programs funded by the FEFP of 131,323.44 FTE over the next three years.

Governor's Budget Recommendations

- No major changes to the FEFP
- Increase in total potential funds of \$991,734,721
 - This is less than half of last year's increase
- Enrollment increase of 1.65%
- BSA of \$5,247.02 or \$107.29 per WFTE
- \$350,000,000 Contingency Fund
