Dear Fort Braden Digital Academy Parent/Guardian,

Testing season is fast approaching. Fort Braden School Digital Academy test dates are as follows:

3rd grade ELA – Wednesday, April 21 and Thursday, April 22

4th – 8th grade Writing – Thursday, April 22

4th and 5th grade ELA – Tuesday, May 4 and Wednesday, May 5

5th grade Science – Tuesday, May 11 and Wednesday, May 12

7th grade Civics – Tuesday, May 11

8th grade Science – Tuesday, May 11

3rd – 8th grade Math – Thursday, May 20 and Friday, May 21

6th – 8th grade ELA – Tuesday, May 26 and Wednesday, May 27

Algebra – Wednesday, June 2 and Thursday, June 3

Per the Florida Department of Education (FDOE), no remote administrations are available for any statewide summative assessments. Digital Academy students will be tested in a dedicated, sanitized testing room, separate from the regular student population. Student will need to be dropped off at the front of the school between 8:40am and 9:00am on testing dates. Students will report to testing rooms upon arrival. Test end times will differ depending on test administration and you will be notified via email.

Please review the following policies with your student before testing:

- **Electronic Devices**—Students are not permitted to have any electronic devices, including, but not limited to, cell phones, smartphones, and smartwatches, at any time during testing **or** during breaks (e.g., restroom), **even if the devices are turned off or students do not use them**. If your student is found with an electronic device, his or her test will be invalidated.
- **Calculators**—Calculators are not permitted during Grades 3–6 Mathematics tests.

- **Testing Rules Acknowledgment**—All tests include a Testing Rules Acknowledgment printed in the student’s test and answer book or in the secure testing browser (7th and 8th grade) that reads: “I understand the testing rules that were just read to me. If I do not follow these rules, my test score may be invalidated.” Prior to testing, test administrators read the rules to students, and students acknowledge that they understand the testing rules by signing below the statement in their test and answer book or clicking the “acknowledgement” button in the testing browser.
- **Discussing Test Content after Testing**—The last portion of the testing rules read to students before they sign below the Testing Rules Acknowledgment states: “Because the content in all statewide assessments is secure, you may not discuss or reveal details about the test content (including test items, passages, and prompts) after the test. This includes any type of electronic communication, such as texting, emailing, or posting to social media sites.” Please make sure your student understands this policy prior to testing and remind them that “discussing” test content includes any kind of electronic communication, such as texting, emailing, posting to social media, or sharing online. **While students may not share information about secure test content after testing, this policy is not intended to prevent students from discussing their testing experiences with their parents/families.**
- **Working Independently**—Students are responsible for doing their own work during the test and for protecting their answers from being seen by others. If students are caught cheating during testing, their tests will be invalidated. In addition, FDOE employs Caveon Test Security to analyze student test results to detect unusually similar answer patterns. Student tests within a school that are found to have extremely similar answer patterns will be invalidated.
- **Leaving Campus**—If your student leaves campus before completing a test session (e.g., for lunch, an appointment, illness), he or she **will not** be allowed to return to that test session. If your student does not feel well on the day of testing, it may be best for him or her to wait and be tested on a make-up day. Please remember not to schedule appointments on testing days.
- **Testing Accommodations**—If your student has an Individual Education Plan (IEP), a Section 504 plan, or is an English Language Learner (ELL) or a recently exited ELL, please contact the school to discuss the testing accommodations that will be provided for your student.
