# Off-Campus Lunch Pass Application 2024-25 school year

Off-campus lunch privilege is reserved for **classified Senior & Juniors** in accordance with Leon County School policy 3.03(8).

#### What you need to obtain an off-campus lunch pass:

- 1. Must be classified as a Junior or Senior in your correct cohort and have earned at least a 2.0 unweighted GPA or higher cumulatively, or during the preceding nine-week grading period, to be eligible.
- 2. Parent/Guardian Signature MUST BE LEGALLY NOTARIZED\* (signed in front of a notary public) **OR** the parent/guardian may sign this form in front of a staff member while physically present at the school.
- 3. Students must be clear of all attendance failures and Obligations (Fines/fees, Chromebooks etc. if list is available)
- 4. Student must have a school-issued Student ID card to place to pass on.

### **Off-campus Pass Infractions:**

- 1. Students with an off-campus pass will not take any student off campus who is not authorized to leave. This includes other juniors and seniors who do not have an off-campus pass.
- 2. Must maintain a 2.0 unweighted GPA each 9-weeks.
- 3. Reckless driving, speeding, not wearing seat belts, or other driving violations.
- 4. More than three tardies to 5<sup>th</sup> period after lunch.
- 5. Failing to return to class after lunch without signing out in the Attendance Office prior to departing for lunch.
- 6. Two referrals within 30 days will result in suspension of pass.
- 7. Drugs, alcohol, tobacco or weapons found in any vehicle will result in revocation.
- 8. Attendance failure(s) (\* The Attendance Office holds the right to revoke my pass)

### **Off-campus Pass Consequences:**

- 1. Suspension of off-campus and/or parking privileges.
- 2. Revocation of off-campus and/or parking privileges.
- 3. Lunch Detention or ISS.
- 4. Out of School Suspension.
