ACTION REQUESTED: ACTION REQUESTED: The Superintendent recommends approval of the recommendation to award and purchase order to CSI Contracting, Inc.., the prequalified, responsible and responsive bidder meeting all requirements, and who submitted the lowest bid in the amount of \$125,513.00.

ITEM SUMMARY: The Facilities and Construction Department issued an Invitation to Bid (ITB) 5688- Killearn Lakes Elementary School Basketball Court Reconstruction Project. Four (4) Contractors submitted bids in response to the above referenced Invitation to Bid. It is recommended that Bid 5688-2022 Killearn Lakes Elementary School Basketball Court Reconstruction Project be awarded to the prequalified, responsible and responsive bidder meeting all requirements, CSI Contracting, Inc.., in the amount of \$123,133.00 and a lump sum bid for 2,400 square feet of sod replacement in the amount of \$2,380.00 for a total amount of \$125,513.00. CSI Contracting, Inc. submitted a price per square foot for additional sod replacement in excess of 2,400 square feet in the amount of \$0.95 per square foot.

The recommended construction delivery method for this project is Bid. The scope of work is defined as Killearn Lakes Elementary School Basketball Court Reconstruction. District staffing is sufficient to provide the type of supervision needed on this project and has recent experience with similar projects. Costs will be monitored to ensure we stay within budget.

CSI Contracting, Inc. has earned an estimated amount of \$ 0.00 of projects over the past three (3) years.
