- 1. **SHEET E1.0, FIRE ALARM PROJECT NOTES:** Delete Note #17. A general alarm shall NOT shutdown all AHUs.
- 2. <u>SHEET E3.1, NEW WORK NOTES</u>: Note #5 shall be modified to read: "Existing flow and tamper switches shall remain. Contractor shall test and verify proper operation. Provide addressable modules for monitoring by the new Fire Alarm System".
- 3. **SHEET E3.1, NEW WORK NOTES:** Note #6 shall be deleted. No gas valve work shall be included in the project.
- SHEET E3.1, NEW WORK NOTES: Note #7 shall be modified to read: "Fire Alarm Contractor shall coordinate new Fire Alarm Panel wiring and connections with existing elevator controls. The existing elevator controls shall remain.
