ACTION REQUESTED: The Superintendent recommends Board approval for the negotiation with the architectural firm of Clemons Rutherford and Associates, Inc. the highest ranked firm for J. Michael Conley Elementary School School Wide Exterior Plaster Replacement Project, in accordance with F.S. Chapter 287.055, "Consultant's Competitive Negotiations Act." Should this negotiation fail with Clemons Rutherford and Associates, Inc. then request permission to negotiate with the next ranked firm. Once negotiations have been finalized, the contract will be submitted to the Board for approval.

ITEM SUMMARY: The committee for the appointment of architects convened on October 28, 2020 to interview architectural firms for J. Michael Conley Elementary Schoo, School Wide Exterior Plaster Replacement Project. Five (5) firms submitted qualification statements for this project, of which five (5) were selected to interview. The committee ranked the firms as follows:

- 1. Clemons Rutherford and Associates, Inc.
- 2. MLD Architects, LLC
- 3. Architects Lewis+Whitlock
- 4. 4M Design Group, PA
- 5. Hammond Design Group, LLC

The total estimated construction budget J. Michael Conley Elementary School, School Wide Exterior Plaster Replacement Project is \$1,900,500.00.

The recommended construction delivery method for this project is Construction Management. Major tasks will be defined but there is potential for unknown conditions and the need to work around the schools schedule. The type of work is not unique but coordination and timing of all the required trades is complicated. District staffing is not sufficient to provide the type of supervision needed on this project during the busy summer construction session.

Clemons Rutherford and Associates, Inc. has earned \$0.00 of Leon County School Board projects over the last 3 years.

This is not a phased project.
