ITEM SUMMARY: An advertisement was published once a week for three consecutive weeks in the Tallahassee Democrat and on our Purchasing website for RFQ 480-2022 Continuing Contract for Construction Management Consulting Services for Projects Estimated Less Than \$1,500,000. Eleven (11) firms submitted the required documentation for qualification. The Short List Committee evaluated the presentations and ranked the firms in the order set forth above. The Superintendent recommends that the Board approve the recommended ranking of qualified firms set forth above, and award the attached Continuing Contracts. The term of the contract shall be from August 24, 2021 through June 30, 2023.

Projects will be issued in rotating order based on the rankings of the Interview Committee. As specific projects are issued, a project specific Contract will be submitted to the Board for approval.

The selection process for continuing contracts for Construction Management Consulting Services with budgets less than \$1,500,000, is governed by LCS Policy 6320.02 and state law.

Ties for final order of ranking were determined using the criteria listed below:

- 1. Drug-Free Workplace
- 2. Local Vendor (School Board Policy 6450)
- 3. Leon County School Small Business Entity
- 4. Coin Toss
