Pursuant to Section 287.055, Florida Statutes, and the Chapter 6A-2.0010, F.A.C. the Leon County School Board, is seeking Construction Managers at Risk under Florida Statutes 1013.45(c), for a Continuing Contract for district-wide facilities, including, but not limited to the following: construction, additions, remodeling and renovations, and site improvement projects estimated less than \$1,500,000.

In accordance with State Requirements for Educational Facilities (S.R.E.F.), 2014, Chapter 4, Section 4.1, Prequalification of Contractors for Educational Facilities Construction: **ONLY** contractors who hold a current Leon County School Board - Prequalification Certificate may submit their qualifications.
