**ACTION REQUESTED:** The Superintendent recommends Board approval of the following firms Continuing Contract for Emergency Construction Services for Construction Projects with Budgets Less Than \$1,500,000: (1) Rippee Construction, Inc., (2) RAM Construction and Development, LLC, (3) Cook Brothers, Inc., authorize the Chair/Vice Chair or Superintendent to sign all related documents and authorize the necessary budget amendments.

**ITEM SUMMARY:** On August 17, 24 and 31, 2015, an advertisement was published in the Tallahassee Democrat and on our Purchasing web site for RFQ 350-2016 Continuing Contract for Emergency Construction Services for Construction Projects with Budgets Less Than \$1,500,000. Fourteen (14) firms submitted the required documentation for qualification. Based on the rankings of the Short List Committee, the District identified five (5) firms to make public presentations to an Interview Committee. Based on the rankings of the Interview Committee, the District recommends three (3) firms deemed to be the most highly qualified to perform the required services for each proposed project. Upon approval of the recommendation Continuing Contracts for each firm will be brought to the Board for approval on November 17, 2015. Projects will be issued in rotating order based on the rankings of the Interview Committee. As specific projects are issued, a project specific Contract will be submitted to the Board for approval and Authorized by the Chair/Vice Chair or Superintendent to sign all related documents and authorize the necessary budget amendments. The term of the contract shall be from November 17, 2015 through June 30, 2016. Selections were made in accordance with Florida Statutes and Leon County School Board Policies.
