ACTION REQUESTED: The Superintendent recommends Board action to approve the negotiation with Rippee Construction, Inc. the highest ranked firm for the Construction Manager at Risk Services for Astoria Park Elementary School, Building 01 Administration Area Finishes, Canopy Replacement and Drainage Project, in accordance with F.S. Chapter 287.055, "Consultant's Competitive Negotiations Act." Should this negotiation fail with Rippee Construction, Inc. then request permission to negotiate with the next ranked firm. Documents are currently at 100% complete and once negotiations have been finalized, the Guaranteed Maximum Price (GMP) contract will be submitted to the Board for approval.

ITEM SUMMARY: The interview committee for the Construction Manager at Risk Services convened on August 29, 2016 to interview construction management firms for Astoria Park Elementary School, Building 01 Administration Area Finishes, Canopy Replacement and Drainage Project. Eleven (11) firms submitted qualification statements for this project, of which five (5) were selected to interview. The committee ranked the firms as follows:

- 1. Rippee Construction, Inc.
- 2. RAM Construction & Development, LLC
- 3. Cook Brothers, Inc.
- 4. Childers Construction Co., Inc.
- Sperry & Associates, Inc.

The total estimated construction budget for Astoria Park Elementary School is \$1,275,000.00.

The recommended construction delivery method for this project is Construction Management. Delivery Method analysis is attached.

Rippee Construction, Inc. has earned an estimated amount of \$9,011,585.94 of projects over the past 5+ years.
