**ACTION REQUESTED:** The Superintendent recommends Board action to approve the negotiation with Rippee Construction, Inc. the highest ranked firm for the Construction Manager at Risk Services for Godby High School, Chiller, Stage Lighting, Window Replacement and Clinic Upgrades Project, in accordance with F.S. Chapter 287.055, "Consultant's Competitive Negotiations Act." Should this negotiation fail with Rippee Construction, Inc. then request permission to negotiate with the next ranked firm. Documents are currently at 100% complete and once negotiations have been finalized, the Guaranteed Maximum Price (GMP) contract will be submitted to the Board for approval.

**ITEM SUMMARY:** The interview committee for the Construction Manager at Risk Services convened on September 14, 2016 to interview construction management firms for Godby High School, Chiller, Stage Lighting, Window Replacement and Clinic Upgrades Project. Thirteen (13) firms submitted qualification statements for this project, of which five (5) were selected to interview. After a tabulation of the rankings there was a tie for the rankings of 2, 3 and 4. In the case of a tie between two or more prospective contractors, the Committee applied criteria derived from Section 60A-1.011, F.A.C. and 295.187(4), F.S. to break the tie. The firms are ranked as follows:

- Rippee Construction, Inc.
- Cook Brothers, Inc.
- 3. Childers Construction Co., Inc.
- RAM Construction & Development, LLC
- Culpepper Construction Company, Inc.

The total estimated construction budget for Godby High School is \$2,613,750.00.

The recommended construction delivery method for this project is Construction Management. Delivery Method analysis is attached.

Rippee Construction, Inc. has earned an estimated amount of \$9,011,585.94 of projects over the past 5+ years.
