ACTION REQUESTED: The Superintendent recommends Board action to approve negotiation with the architectural firm of Hoy + Stark Architects, P.A. the highest ranked firm for Sealey Elementary School Administration Renovations with Security and Code Upgrades Project, in accordance with F.S. Chapter 287.055, "Consultant's Competitive Negotiations Act." Should this negotiation fail with Hoy + Stark Architects, P.A., then request permission to negotiate with the next ranked firm. Once negotiations have been finalized, the contract will be submitted to the Board for approval.

ITEM SUMMARY: The committee for the appointment of architects convened on March 21, 2017 to interview architectural firms for Sealey Elementary School Administration Renovations with Security and Code Upgrades Project. Seven (7) firms submitted qualification statements for this project, of which five (5) were selected to interview. The committee ranked the firms as follows:

- 1. Hoy+Stark Architects, P.A.
- 2. DAG Architects, Inc.
- 3. Barnett Fronczak Barlowe Architects
- 4. Emo/Architects, Inc.
- 5. Clemons Rutherford and Associates, Inc.

The total estimated construction budget for Sealey Elementary School is \$500,000.00.

The recommended construction delivery method for this project is Construction Management. Delivery Method analysis is attached.

Hoy + Stark Architects, P.A.. has earned \$1,012,550.58 of Leon County School Board projects over the last 5+ years.
