**ACTION REQUESTED:** The Superintendent recommends Board approval for the negotiation with the architectural firm of Hoy+Stark Architects, P.A. the highest ranked firm for Rickards High School New Construction, Remodeling and Renovations & Site Improvements Project, in accordance with F.S. Chapter 287.055, "Consultant's Competitive Negotiations Act." Should this negotiation fail with Hoy+Stark Architects, P.A. then request permission to negotiate with the next ranked firm. Once negotiations have been finalized, the contract will be submitted to the Board for approval.

**ITEM SUMMARY:** The committee for the appointment of architects convened on October 18, 2017 to interview architectural firms for Rickards High School New Construction, Remodeling and Renovations & Site Improvements Project. Nine (9) firms submitted qualification statements for this project, of which five (5) were selected to interview. The committee ranked the firms as follows:

- 1. Hoy+Stark Architects, P.A.
- 2. DAG Architects, Inc.
- 3. Barnett Fronczak Barlowe Architects
- 4. Clemons, Rutherford and Associates, Inc..
- 5. EMO Architects, Inc.

The total estimated construction budget Rickards High School New Construction, Remodeling and Renovations & Site Improvements Project is \$30,000,000.00.

The recommended construction delivery method for this project is Construction Management. Delivery Method analysis is attached.

Hoy+Stark Architects, P.A. has earned \$521,496.70 of Leon County School Board projects over the last 3 years.

This is a phased project as funds become available.
