ACTION REQUESTED: The Superintendent recommends Board approval to approve negotiation with the engineering firm of Dewberry Engineers, Inc. d/b/a Dewberry/Preble-Rish the highest ranked firm for RFQ 413-2018 Civil Engineer Consulting Services for Woodville K-8 School Site Improvements Project, in accordance with F.S. Chapter 287.05 Dewberry Engineers, Inc. d/b/a Dewberry/Preble-Rish then request permission to negotiate with the next ranked firm. Once negotiations have been finalized, the contract will be submitted to the Board for approval.

ITEM SUMMARY: The committee for the appointment of engineers convened on October 16, 2017 to interview engineering firms for RFQ 413-2018 Civil Engineer Consulting Services for Woodville K-8 School Site Improvements Project. Four (4) firms submitted qualification statements for this project, of which four (4) were selected to interview. The committee ranked the firms as follows:

- 1. Dewberry Engineers, in. d/b/a Dewberry/Preble-Rish
- 2. George & Associates, Consulting Engineering, Inc.
- 3. Spectra Engineering & Research, Inc.
- 4. GGI, LLC dba Genesis

The total estimated construction budget for RFQ 413-2018 Civil Engineer Consulting Services for Woodville K-8 School Site Improvements Project is \$1,500,000.00.

Dewberry Engineers, Inc. d/b/a Dewberry/Preble-Rish has earned \$2,600.00 of Leon County School Board projects over the last 3 years.

*** (under previous name) Dewberry Engineers earned 0.00 of Leon County School Board projects over the last 3 years. (under previous name) Preble-Rish earned \$49,400.00 of Leon County School Board projects over the last 3 years.

The recommended construction delivery method for this project is Construction Management. Major tasks are defined but there is potential for unknown conditions and the need to work around the schools schedule. The type of work is not unique but coordination and timing of all the required trades is complicated. District staffing is not sufficient to provide the type of supervision needed on this project during the busy summer construction session.
