ACTION REQUESTED: The Superintendent recommends Board approval for the negotiation with the architectural firm of Barnett Fronczak Barlowe & Shuler Architects the highest ranked firm for Fairview Middle School New Construction, Remodeling and Renovations & Site Improvements Project, in accordance with F.S. Chapter 287.055, "Consultant's Competitive Negotiations Act." Should this negotiation fail with Barnett Fronczak Barlowe& Shuler Architects then request permission to negotiate with the next ranked firm. Once negotiations have been finalized, the contract will be submitted to the Board for approval.

ITEM SUMMARY: The committee for the appointment of architects convened on October 19, 2017 to interview architectural firms for Fairview Middle School New Construction, Remodeling and Renovations & Site Improvements Project. Nine (9) firms submitted qualification statements for this project, of which five (5) were selected to interview. The committee ranked the firms as follows:

- 1. Barnett Fronczak Barlowe & Shuler Architects
- 2. MLD Architects, LLC
- 3. Clemons, Rutherford and Associates, Inc.
- 4. DAG Architects, Inc.
- 5. EMO Architects, Inc.

The total estimated construction budget Fairview Middle School New Construction, Remodeling and Renovations & Site Improvements Project is \$20,000,000.00.

The recommended construction delivery method for this project is Construction Management. Major tasks will be defined but there is potential for unknown conditions and the need to work around the schools schedule. The type of work is not unique but coordination and timing of all the required trades is complicated. District staffing is not sufficient to provide the type of supervision needed on this project during the busy summer construction session.

Barnett Fronczak Barlowe & Shuler Architects has earned \$423,537.00 of Leon County School Board projects over the last 3 years.

This is a phased project as funds become available.
