ACTION REQUESTED: The Superintendent recommends approval of the Interview Committee's recommendation and authorizes the negotiation with Cook Brothers, Inc. the highest ranked firm for the Construction Manager at Risk Services for W.T. Moore Elementary School Chiller and Boiler Replacement Project, in accordance with F.S. Chapter 287.055, "Consultant's Competitive Negotiations Act." Should this negotiation fail with Cook Brothers, Inc. then request permission to negotiate with the next ranked firm. Once documents are complete and negotiations have been finalized, the Guaranteed Maximum Price (GMP) contract will be submitted to the Board for approval.

ITEM SUMMARY: The interview committee for the Construction Manager at Risk Services convened on November 27, 2017 to interview construction management firms for W.T. Moore Elementary School Chiller and Boiler Replacement Project. Five (5) firms submitted qualification statements for this project, of which six (6) were selected to interview. The firms are ranked as follows:

- 1. Cook Brothers, Inc.
- 2. Albritton-Williams, Inc..
- CSI Contracting, Inc.
- 4. Rippee Construction, Inc..
- RAM Construction & Development, LLC

The total estimated construction budget for W.T. Moore Elementary School is \$1,000,000.00.

The recommended construction delivery method for this project is Construction Management. Major tasks are defined but there is potential for unknown conditions and the need to work around the schools schedule. The type of work is not unique but coordination and timing of all the required trades is complicated. District staffing is not sufficient to provide the type of supervision needed on this project during the busy summer construction session.

Cook Brothers, Inc.has earned an estimated amount of \$3,517,137.34 of projects over the past 3 years.
