ACTION REQUESTED: The Superintendent recommends approval of the Interview Committee's recommendation and authorizes the negotiation with RAM Construction & Development, LLC the highest ranked firm for the Construction Manager at Risk Services for Fairview Middle School New Construction, Remodeling, Renovations and Site Improvements Project, in accordance with F.S. Chapter 287.055, "Consultant's Competitive Negotiations Act." Should this negotiation fail with to RAM Construction & Development, LLC . then request permission to negotiate with the next ranked firm. Once documents are complete and negotiations have been finalized, the Guaranteed Maximum Price (GMP) contract will be submitted to the Board for approval.

ITEM SUMMARY: The interview committee for the Construction Manager at Risk Services convened on November 9 2017 to interview construction management firms for Fairview Middle School New Construction, Remodeling, Renovations and Site Improvements Project. Seven (7) firms submitted qualification statements for this project, of which five (5) were selected to interview. The firms are ranked as follows:

- 1. RAM Construction & Development, LLC
- Allstate Construction, Inc.
- 3. Culpepper Construction Company, Inc.
- 4. Rippee Construction, Inc.
- Cook Brothers, Inc.

Total Estimated Construction Budget \$20,000,000.00. This is a phased project as funds become available.

The recommended construction delivery method for this project is Construction Management. Major tasks are defined but there is potential for unknown conditions and the need to work around the schools schedule. The type of work is not unique but coordination and timing of all the required trades is complicated. District staffing is not sufficient to provide the type of supervision needed on this project during the busy summer construction session.

RAM Construction & Development, LLC.has earned an estimated amount of \$19,406,862.92 of projects over the past 3 years.
