**ACTION REQUESTED:** The Superintendent recommends Board approval to approve negotiation with the engineering firm of George & Associates, Consulting Engineers, Inc. the highest ranked firm for RFQ 430-2018 Civil Engineering Consulting Services for Chiles High School Site Improvements and Site Expansion Project, in accordance with F.S. Chapter 287.05 George & Associates, Consulting Engineers, Inc. then request permission to negotiate with the next ranked firm. Once negotiations have been finalized, the contract will be submitted to the Board for approval.

**ITEM SUMMARY:** The committee for the appointment of engineers convened on March 16, 2018 to interview engineering firms for RFQ 430-2018 C Civil Engineering Consulting Services for Chiles High School Site Improvements and Site Expansion Project. Five (5) firms submitted qualification statements for this project, of which five (5) were selected to interview. After a tabulation of the rankings there was a tie for the rankings of 1 and 2. In the case of a tie between two or more prospective contractors, criteria was applied derived from Section 60A-1.011, F.A.C. and 295.187(4), F.S. to break the tie. The committee ranked the firms as follows:

- 1. George & Associates, Consulting Engineers, Inc.
- 2. GGI, LLC dba Genesis
- 3. Dewberry Engineers, in. d/b/a Dewberry/Preble-Rish
- 4. Urban Catalyst Consultants, Inc.
- 5. Spectra Engineering & Research, Inc.

The total estimated construction budget for RFQ 430-2018 Civil Engineering Consulting Services for Chiles High School Site Improvements and Site Expansion Project is \$2,500,000.00.

George & Associates, Consulting Engineers, Inc. has earned \$0.00 of Leon County School Board projects over the last 3 years.

The recommended construction delivery method for this project is Construction Management. Major tasks are defined but there is potential for unknown conditions and the need to work around the schools schedule. The type of work is not unique but coordination and timing of all the required trades is complicated. District staffing is not sufficient to provide the type of supervision needed on this project during the busy summer construction session.
