ITEM SUMMARY: On April 13, 20 and 27, 2018, an advertisement was published in the Tallahassee Democrat and on our Purchasing web site for RFQ 441-2018 Continuing Contract for Professional Architectural Consulting Services for Projects Estimated Less Than \$1,500,000. Ten (10) firms submitted the required documentation for qualification. The Short List Committee evaluated the presentations and ranked the firms in the order set forth above. The Superintendent recommends that the Board approve the recommended ranking of qualified firms set forth above, and award the attached Continuing Contracts. The term of the contract shall be from November 20, 2018 through June 30, 2020. Projects will be issued in rotating order based on the rankings of the Interview Committee. As specific projects are issued, a project specific Contract will be submitted to the Board for approval.

The selection process for continuing contracts for Professional Architectural Consulting Services with budgets less than \$1,500,000, is governed by LCS Policy 6320.02 and state law.

Ties for order of ranking were determined using criteria listed below:

1. Leon County School Small Business Entity
2. Location of respondent's office to the Facility and Construction Office.

Failure to file a protest within the time prescribed in section 120.57(3), Florida Statutes, or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under chapter 120, Florida Statutes.
