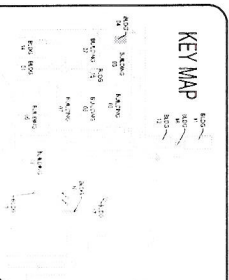
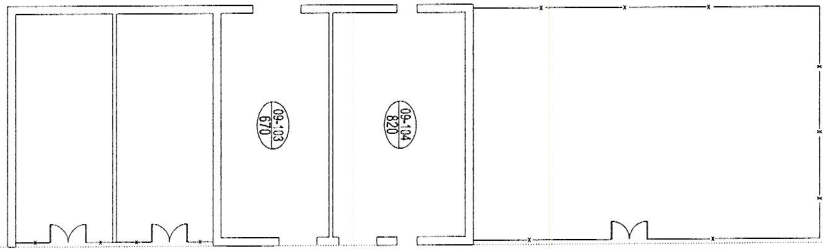
BUILDING 04 (04-100)



BUILDING 10 (10-100)

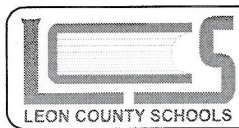

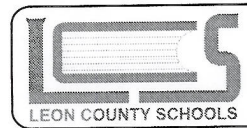


BUILDING 06 (06-100)

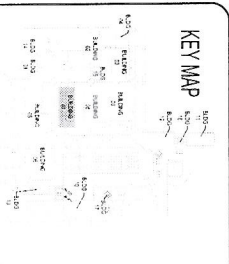

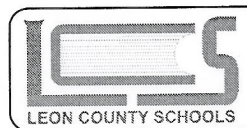

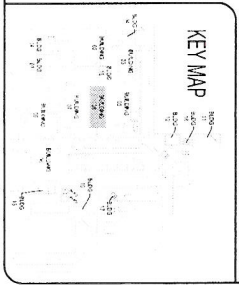

2ND FLOOR



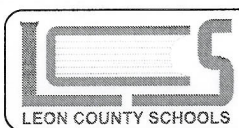

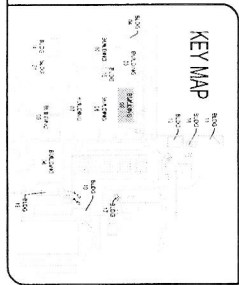

2ND FLOOR

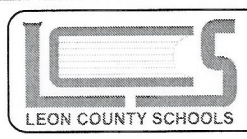

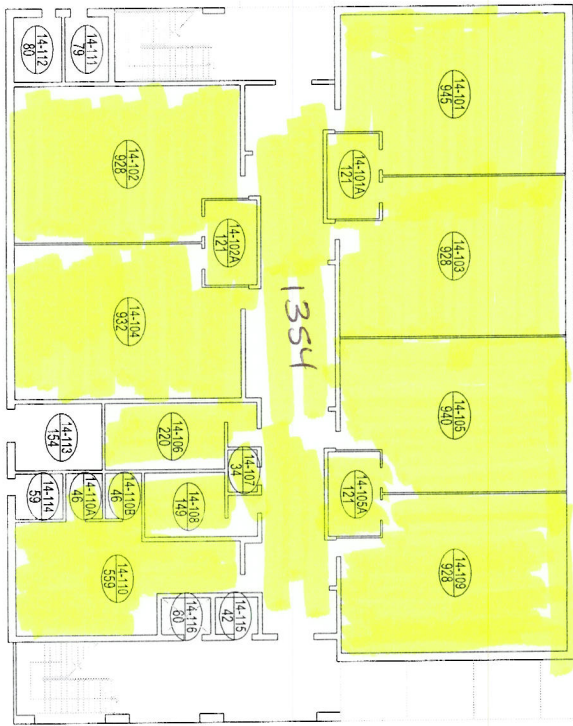

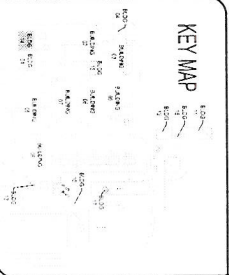

1ST FLOOR



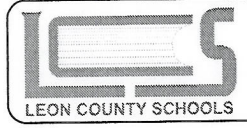
