ACTION REQUESTED: Th Fitzgerald Collaborative Group, LLC is the highest ranked firm for W.T. Moore Elementary School, New Construction, Remodeling, Renovations and Site Improvements Classroom Redesign Project, per Chapter 287.055, Florida Statute, "Consultant's Competitive Negotiations Act." Should negotiations fail with Fitzgerald Collaborative Group, LLC, the District will move forward in negotiations with the next highest-ranked firm. Once negotiations have been finalized, the contract will be submitted to the Board for approval.

ITEM SUMMARY: The committee for the recommendation of architects convened on August 10, 2022, to interview architectural firms for the W.T. Moore Elementary School, New Construction, Remodeling, Renovations, and Site Improvements Classroom Redesign Project. Six (6) firms submitted qualification statements for this project, of which six (6) were selected to interview. The committee ranked the firms as follows:

1. Fitzgerald Collaborative Group, LLC
2. MLD Architects, LLC
3. Architects Lewis+Whitlock, PA
4. Hoy+Stark Architects, P.A.
5. JRA Architects, LLC
6. Barnett Fronczak Barlowe & Shuler Architects

The total estimated construction budget for W.T. Moore Elementary School, New Construction, Remodeling, Renovations, and Site Improvements Classroom Redesign Project is \$7,500,000.00.

The recommended construction delivery method for this project is Construction Management. Major tasks are defined, but there is potential for unknown conditions and the need to work around the school's schedule. The type of work is not unique, but the coordination and timing of all the required trades is complicated. District staffing is insufficient to provide the type of supervision needed on this project.

Fitzgerald Collaborative Group has earned \$0.00 from Leon County School Board projects over the last three years.

This will be a phased project.

Per Section 120.57(3), Florida Statutes (F.S.), a Notice of Intent to Protest or a Formal Written Protest must be filed with the District's Purchasing Department within the timeframes established in law. Failure to file a protest within the time prescribed in Section 120.57(3), F.S., or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, F.S.
