ACTION REQUESTED: The Superintendent recommends award and subsequent purchase order to Ferrara Consultants and Space Age Roof Tech, LLC., the prequalified and responsible bidder who submitted the lowest responsive total base bid for the KEE cap hybrid system (including a 30-year manufacturer's NDL, edge-to-edge warranty) of \$2,634,400.00.

ITEM SUMMARY: The Facilities and Construction Department issued an Invitation to Bid (ITB) 5698-2023 for W.T. Moore Elementary School, Roof Replacement Project, which contemplated options for two (2) different roofing systems; PVC, which is the older type of roofing material currently in use, and the KEE cap hybrid system, which is more modern and provides better flexibility resulting in fewer leaks and longer life. Due to the cost difference between the products, especially in the current climate of inflation and supply chain issues, the District wanted to evaluate the cost difference between the options. Seven (7) contractors submitted bids in response to the ITB, one (1) vendor was deemed non-responsive, one submitted no response to the KEE cap hybrid system, and one vendor withdrew their bid due to staffing shortages.

It is recommended that ITB 5698-2023, W.T. Moore Elementary School, Roof Replacement Project be awarded to the pre-qualified and responsible bidder, Ferrara Consultants and Space Age Roof Tech, LLC, who submitted the lowest responsive total base bid for the KEE cap hybrid system (including a 30-year manufacturer's NDL, edge-to-edge warranty) of \$2,634,400.00. Based on the pricing received, the cost difference was lower than we anticipated, and moving forward with the KEE cap hybrid with a 30-year warranty was the best value for the District.

Ferrara Consultants and Space Age Roof Tech, LLC. is a pre-qualified vendor with Leon County Schools and has met all pre-qualification requirements, including minimum insurance coverage. The District's Contract Manager maintains proof of required insurance as part of the Contract Management file. Additionally, Contractors are required to provide proof of insurance before the issuance of permits.

The recommended construction delivery method for this project is Bid. The scope of work is defined as W.T. Moore Elementary School, Roof Replacement Project. District staffing is sufficient to provide the type of supervision needed on this project, and has recent experience with similar projects. Costs will be monitored to ensure we stay within budget.

Ferrara Consultants and Space Age Roof Tech, LLC. has earned an estimated \$5,407.50 for projects over the past three (3) years.
