REGISTRATION CHECKLIST

Documentation: In addition to the registration form, **you must have with you the following when registering a new student (please understand we CANNOT enroll your student without these documents):**

_____ **PARENT/GUARDIAN'S DRIVER'S LICENSE OR STATE ISSUED PHOTO ID** (used to verify identity of individual registering student) Only a parent of legal guardian can register a student.

_____ **PROOFS OF RESIDENCE FOR LEON COUNTY** Parent or legal guardian enrolling student must live in the School Zone. (Anyone other than a parent attempting to enroll a minor student must show proof of legal guardianship) *You must present these even if you are reassigned.*

- a. Lease/Mortgage/Property Tax Record/Homestead Exemption
- b. Cable Bill/Home Phone Bill/Utility Bill

_____ **GUARDIANSHIP PAPERWORK** only required if you are not the parent as recorded on the student's official birth certificate.

_____ **COPY OF BIRTH CERTIFICATE**

_____ **COPY OF SOCIAL SECURITY CARD** (not required by law)

_____ **IMMUNIZATION RECORD**

HRS 680 (must be a Florida Shot record on form HRS 680 can be obtained from Health Dept. or Doctor's office)

_____ **HEALTH CERTIFICATE**

Physical within one year if enrolling in Leon County Schools for the 1st time or from out of state.

_____ **CURRENT REPORT CARD AND TRANSCRIPT** This is needed to ensure that student is placed at the appropriate grade level courses. It must show proof of promotion. *For pre-registration (prior to the end of the school year), provide the most recent 9 week report card.* Students going into the 10th, 11th, or 12th grade must also provide a current transcript. Documentation must include standardized test information.

_____ **WITHDRAWAL FORM FROM PREVIOUS SCHOOL** (not required when pre-registering for next school year)

_____ **NAME AND MAILING ADDRESS OF PREVIOUS SCHOOL** (If student was home schooled, please provide the last student evaluation.)
