#### **BY LAWS**

OF

#### **LADIES OF DISTINCTION**

#### ARTICLE I

#### **ORGANIZATION**

**Section 1. Status and Name.** This organization shall be Ladies of Distinction.

**Section 2. Principal Address.** The principal address of this club/ organization shall be **550 E. Tennessee Street, Tallahassee Florida 32308.** 

#### ARTICLE II

#### **PURPOSE**

The purpose of this organization is a service organization in which we offer assistance and support to our school as well as our community. Ladies of Distinction will strive to be our best at all times and to carry ourselves with esteem and confidence. Ladies of Distinction have the utmost respect for our school, our community, and for each other.

#### ARTICLE III

#### **MEMBERSHIP**

**Section I. Eligibility. Candidates who seek membership must be currently enrolled** at Leon High School, have a minimum of a 2.5 cumulative Grade Point Average (GPA), and must not be on academic or social probation. Potential members shall complete a membership application and submit club dues of \$25.00. Memberships are valid from June through May of the following year.

**Section 2. Dues.** Membership dues shall be applied once at school term. Club Dues are nonrefundable.

#### ARTICLE IV

#### **MEETINGS**

Meetings will be publicized at least five (5) school days in advance. There must be a meeting at least once a month. There must be quorum (a quorum is 50 percent plus 1 of the active or dues paying membership) present in order to take care of financial action. Standing committee of this club shall be appointed as necessary.

#### **ARTITCLE V**

#### **EXECUTIVE OFFICERS**

**Section 1. Officers**. Officers shall consist of a President, 1st Vice President, 2<sup>nd</sup> Vice President; Treasurer, Assistant Treasurer; Secretary, Assistant Secretary; and Public Relations Coordinator. The general management of the affairs of the Club shall be vested in the **Executive Officers**. The officers shall have specific responsibilities to audit bills and disburse the fund of the Club upon sponsors approval, carry on correspondences and communicate with other associations of the same interest and do any and all other things necessary to carry out the purpose and intent of the Club.

The Executive Officers will formulate policy of the club between regular meetings and in case of emergencies, subject to approval of the general membership. Officers will execute policies determined by the general membership, govern activities of the club and compile agenda for general meetings.

#### **ARTICLE VI**

#### **EXECUTIVE OFFICERS DUTIES.**

**President** shall preside at all regular/special meetings of the Club and Board meeting. The president shall appoint committee, chairperson and conduct/request financial audit upon sponsors' approval. President shall oversee all committee activities.

1st Vice President shall act as the President in the event of his/her absence and shall assume his/her duties. Performs any duties delegated by the president, attend all Inter Club Council meetings, and report the results of ICC meetings at club meetings.

**2nd Vice President** shall act as the 1st Vice President in the event of his/her absences and shall assume his/her duties .Performs any duties delegated by the president, attend all Inter Club Council meetings, and report the results of ICC meetings at club meetings.

**1st Secretaries & 2nd Secretaries**, duties are to keep record of all regular/special meeting. The secretary shall also prepare and maintain a record of all correspondence to the members. Print and distribute agenda for all meetings.

**Treasurer,** will receive all money due to the Ladies of Distinction Club, prepare deposits for sponsors to make school deposit of all cash transactions, provide financial accounts/reports to board and members at each meeting. The treasurer will make disbursements that are approved by the general membership and sponsors to vendors.

**Public Relation**, the duties of informing the public of Ladies of Distinction upcoming events and/or activities, coordinates media events and solicitations of community support.

**The member At Larger,** in the event that all parties of the board are undecided on an issue the member at large will have the final vote on the matter at hand.

#### **ARTICLE VII**

#### **ELECTION PROCEDURES**

**Section 1. Voting.** Voting shall be by secret ballot at the third spring meeting. **All active members must** be present to cast their vote.

**Section 2. Term of Office.** The new officers shall take over their duties on May/June following their election. Officers shall serve for one year, but may not hold office more than two years consecutively in any one position.

**Section 3. Nominating Committee.** This committee shall consist of members of the Club for the purpose of assisting in the selection of the officers for the following year.

**Section 4. Election of Officers.** A Nominating committee will be established each year at the first spring meeting for the purpose of assisting in the selection of officer for the following year. This committee shall consist of active Club members. The nominating committee shall nominate one person for each office. The nominating committee shall choose a nominee for their abilities and willingness to serve the organization.

**Section 5. Officers Eligibility.** Club officer must be currently enrolled at Leon High School, must have a minimum of a 2.5 GPA and must not be on academic or social probation. Those members of the Club who have paid their annual dues shall be considered member in good standing and eligible to hold office or to vote in all future election, unless this provision is waived by the Board.

#### **ARTICLE VIII**

#### IMPEACHMENT/REMOVAL AND

#### REPLACEMENT OF OFFICER AND MEMBERS

All elected officer/club member may be subjected to impeachment and removal by two-third majority vote of the total membership.

Grounds for impeachment are negligence and any misconduct which is damaging to the club. An officer/member may impeached/removed only under the following violations: **ALL school policies, insubordination, and /or club eligibility guidelines.** 

Automatic impeachment/removal for: FIGHTING.

#### **ARTICLE IX**

#### SPONSOR/ADVISOR RESPONSIBILITES

The role of the sponsor/advisor is to serve as the official staff representative, work closely with the club to ensure a cooperative relationship between the sponsor and club membership. Assist each officer of the club and understanding of their duties.

Give particular attention to the financial activities of the group and in order to prevent the incurring debt of organizational debts for succeeding members to pay. Assist students to understand and apply democratic principles within their own organization, and with working with others.

Sponsor/ Advisor shall be present for all official club/organization meetings and activities (business and social), and to advise students of the policies and procedures which they must follow as a club/organization. Sponsor/Advisor will be familiar with the ICC Code, ICC Financial Code, ICC Concession Code, and club financial process.

Sponsor/Advisor shall processes all club/organization requisitions, provide executive office with official copies of all club/organization expenditure, which will require executive officers signature to make sure that the expense are correct within all existing policies.

Sponsor/Advisor shall ensure that all reasonable steps are taken to ensure the safety, and welfare of club members.

#### ARTICLE X

#### **RESPONSIBILITIES**

This club accepts full financial responsibilities for all activities that bear its name as official sponsor, and will adhere to regulations. All publicity for an event must bear the name of the sponsoring club.

#### ARTICLE XI

#### **RIGHT TO ACT**

Any club office, club member does not have the right to incur any debt or become involved in any business under the title or by implying the title of a club in any way unless given authority to do so by the club.

#### ARTICLE XII

#### **AMENDMENTS TO CONSTITUTION**

Any amendment change requires a two-third vote at general club meeting and must then be approved at the ICC Officer Agenda Meeting,
