World's Finest Chocolate Fundraiser Contract

Please review the following rules carefully, sign, and return the contract to Ms. Benette no later than **Wednesday, October 30, 2024**. No chocolate will be checked out until this contract is signed and returned.

1. Parents may check out one (1) box of chocolate at a time and provide the box to their child. If you would like to check out a second (2nd) box to sell, please indicate in the space provided below. No student may have more than 2 boxes at a time.
2. Check-out can happen before or after school. Please contact Ms. Benette to arrange a time to check out a box of chocolate. Students may pick them up with parent/guardian consent.
3. Once the money is turned in for one box (again, no more than two at a time), another box can be checked out.
4. Students may not sell chocolate on school premises during the school day. They may only sell chocolate before or after school.
5. Students are responsible for any stolen or lost chocolate. If they bring their chocolate to school, they must always keep it with them.
6. Students are responsible for the chocolate and or chocolate money. If the student's chocolate or money is stolen or lost, the student must pay for it. There are no additional funds in the 8th account to cover losses. ****IMPORTANT:**
Parents/Guardians MUST pay for unsold chocolate before students can participate in the DC/NYC trip.
7. Once a box is checked out, the money must be turned in by the deadline. Unsold chocolate **CANNOT** be returned.
8. All money for the chocolate fundraiser must be turned in by **Wednesday, November 20.**
9. Money earned will go directly into the 8th-grade trip account and be credited toward your child's trip cost.
