



Read United is an initiative that provides volunteers an opportunity to share the love of reading with children in our community over a week-long event in spring & fall each year; each participating 1st Grade classroom at Title I schools & early childcare programs receives a set of books.

MATHPals, is a mentoring program for kindergarten through third grade students, creates a creative and encouraging environment for learning math by matching caring mentors one-toone with students who need extra help developing essential mathematical skills.



ReadingPals is a statewide early literacy initiative that provides volunteer mentors for students from Pre-k to 3rd grade who may need extra help. Mentors are matched one-to-one with students in Pre-K through third grade.



Smile United, a pediatric dental care initiative, in partnership with Florida Blue and Leon County Schools, provides beneficial dental services to second & sixth grade students in Title I schools across Leon County, including dental assessments, dental cleanings, oral health education, fluoride varnish and sealants.



Volunteer Income Tax Assistance (VITA) this program offers free tax help to low-to moderate-income individuals and families. IRS-certified volunteers provide free basic income tax return preparation with electronic filing to qualified individuals.



Reality Store is a learning experience for young adults with the goal of teaching all students basic skills in financial planning, goal setting, decision making, and career planning. Designed to help young adults examine their attitudes about their futures and career expectations.



The most recent United Way of the Big Bend ALICE Report provides a clear yet startling picture of our neighbors struggling to make ends meet and of those living in poverty. ALICE is the acronym for Asset Limited, Income Constrained, Employed - simply put the working poor. On average, **53%** of households in the Big Bend region cannot afford the basic costs of living. This number equates to over **88,402** families or **220,256** individuals are struggling day-to-day in the Big Bend.

Our strategic direction positions UWBB to be more effective than ever for identifying and addressing the needs of those living in poverty and the working poor. Our goal is to shrink these populations in the future by focusing our collective resources on Economic Development through Workforce Enablement. This is achieved through the focus of three goals which help this population gain access to basic necessities, achieve economic stability and develop skills to either help gain employment or move up the economic ladder. Under these three goals, we have identified funding priority outcomes that anchor these goals. They are: Housing, Early **Learning** (to include elementary age and younger), **Safety Net, Skills Development** and the addition of **Health and Mental Health** take into account the impact that the pandemic had on social isolation, depression, access to healthcare and healthcare disparities.

Economic Empowerment Through Workforce Enablement for Those at or Below The ALICE Threshold



UWBB has long been the region's tri leader for addressing our community's m vital concerns. We also recognize the imp tance of staying relevant by keeping up w those ever growing needs and changir philanthropic landscape.



Today our focus is guided by the ALICE Report and other community data. ALICE is the acronym for Asset Limited, Income Constrained, Employed - those living in poverty and at the edge of poverty. The most recent Report provides clear yet startling pictures of our neighbors struggling to make ends meet and of those living in poverty. On average, 53% of households in the Big Bend region cannot afford the basic costs of living; a number which equates to over 88,402 struggling families or 220,256 individuals. Our strategic direction positions UWBB to be more effective than ever in serving as the trusted strategic leader and convener for identifying and addressing the needs of families in the ALICE population.



ReadingPals is an Early Learning initiative administered through a partnership between UWBB and Leon County Public Schools with the help of local community partners providing volunteer mentors for students from Voluntary Prekindergarten (VPK) to 3rd Grade who may need extra help; utilizing one-on-one or small group settings, it builds meaningful relationships with young children helping them to improve social-emotionaldevelopment and early learning literacy skills.

Over the course of the 2024-2025 school year, **98** children in **17** elementary schools including a Pre-K program received 2,428 hours of mentoring and early literacy and reading skills practice to support reading comprehension by 91 mentors trained to use literacy lessons and activities developed by educators. Our ReadingPal children participants are pre-and post-tested on reading skills, and 90% of them made literacy gains, as measured by school administered standardized assessments.

MATHPals is an education initiative with one-to-one matching of caring mentors with



elementary school students in extra need of help developing essential math skills; mentors choose the school and day that best fits their schedule reporting during after-school programs for one hour/week throughout the school year utilizing math curriculum created by UWBB and 100% of them made literacy gains, as measured by school administered standardized assessments.

The **REALITY STORE** is a financial simulation where teenage students are assigned careers and make real world decisions about budgets & lifestyles providing a fun and effective way for teens to learn basic skills in financial planning & responsibility, goal setting, decision making and career planning as well as clarifying the need for young women and men to examine their attitudes about their future and career expectations.

United Way of the Big Bend (UWBB) has been serving our community since 1943. We are the area's only nonprofit supporting 31 partner agencies and providing funding to help support programs that provide critical services to individuals and families in our region.



To make an impact in our community, we focus on five community outcomes, providing grants in these areas:

- HOUSING Increase access to dependable housing, sustainable utilities, and safe neighborhoods.
- **EARLY LEARNING** Increase families' access to steady, affordable, and high-quality care and education.
- **SAFETY NET** Provide consistent safety net services during times of financial stress.
- (A) HEALTH & MENTAL HEALTH Provide affordable health and mental health resources.
- SKILLS DEVELOPMENT Promote educational attainment and development of necessary skills to meet future employment needs and secure self-sustaining jobs.

If you choose to partner with us, we work on partnerships in any of these four ways:

- **Corporate Donation or Sponsorship Opportunity** A donation made on behalf of the company, or the company matches what employees give. Sponsorship opportunities vary based on areas of interest.
- Workplace Giving Campaign Nominate an Employee Campaign Champion (ECC). Present employees with information about United Way. We are happy to come give a brief presentation and will invite a partner agency to also participate if desired. Employees may choose to give through payroll deduction, cash, check, or invoice.
- **Special Events** We work with your HR department and provide a resource guide to help plan activities that focus on fun team building opportunities. Funds raised benefit the United Way.

 - Emerging Leaders United a community engagement and networking group for professionals under the age of 40.
 - Community Investment Team community volunteers who help to allocate funds raised.
 - County Campaign Team Member community volunteers tasked with fundraising in their county.

ReadingPals is a statewide early literacy initiative that provides volunteer mentors for students from Pre-k to 3rd grade who may need extra help. Mentors are matched one-to-one with students in Pre-K through third grade.



MATHPals, a mentoring program for kindergarten through third grade students, creates a creative and encouraging environment for learning math by matching caring mentors one-to-one with students who are in need of extra help developing essential mathematical skills.



Read United is an initiative that provides volunteers an opportunity to share the love of reading with children in our community over a week-long event in early spring and fall each year; each participating 1st Grade classroom at Title I schools & early childcare programs receives a set of books.



Reality Store is a learning experience for young adults with the goal of teaching all students basic skills in financial planning, goal setting, decision making, and career planning. Designed to help young adults examine their attitudes about their futures and career expectations.



Volunteer Income Tax Assistance (VITA) program offers free tax help to low- to moderate-income individuals and families. IRS-certified volunteers provide free basic income tax return preparation with electronic filing to qualified individuals.



SMILE UNITED, a pediatric dental care initiative, provides beneficial dental services to second & sixth grade students in Title I schools across Leon & Gadsden Counties.
