# Bylaws of the Rickards High School Black History Brain Bowl Team

# Article One: Organizational Status

- **A.** The name of the organization shall be the Rickards High School Black History Brain Bowl Team, hereinafter referred to as the "Brain Bowl Team."
- B. Organization Address: 3013 Jim Lee Road, Tallahassee, Florida 32301

# Article Two: Purpose

The purpose of the RHS Black History Brain Bowl Team is to foster achievement in all areas of academics through quiz tournaments and other academic trivia-style competitions.

#### **Article Three: Officers**

The RHS Black History Brain Bowl Team will not have regular officers serving to run or hold order in club activities. However, "team captains" shall be designated in play at competitions. These "captains" shall be chosen based upon player preferences, practice attendance, and team seniority.

## **Article Four: Qualifications**

Black History Brain Bowl Team membership is open to any interested student at Rickards High School. Attendance at team practices is a major component of player status and, along with academic and team seniority, will be used to determine the order and amount of time a member receives in competitive play.

### **Article Five: Sponsor**

The team sponsor, who shall be a member of the faculty or staff of Rickards High School, shall retain the right to

- 1. Total discretion on all activities, meetings, and conferences (both in state and out of state).
- 2. Responsibility to maintain good work ethic from the officers in order to better the club and keep it active
- 3. Ability to void any plans, activities, events, and ideas if thought to be in violation of either RHS, Leon County, State of Florida, or the US Government.

## **Article Six: Dues**

At present, there are no dues associated with membership on the Black History Brain Bowl team. However, students may be required to bring money with them in order to pay for personal expenses and some meals when the team travels for competitions and a team shirt.

**Article Seven: Changes to By-Laws** 

Changes to the team by-laws may be made through a proposal to the team sponsor by any member.

After sponsor and school administration approval, the organization members shall vote on the proposed

change in by-laws before it is adopted.

**Article Eight: Disputes and Grievances** 

In result of any disputes and grievances, please adhere to the following to resolve:

A. The respect and civility (see Addendum 1) adopted at the district level and mandated for all

Leon County Schools shall serve as the guiding document for the conduct and communication by and between members of the RHS Black History Brain Bowl Team, nonmembers who participate in fundraising activities and any other individuals or groups interacting with members related to

RHS Brain Bowl Team.

B. Disputes between individuals or groups affiliated with the RHS Black History Brain Bowl Team that these individuals or groups cannot bring to amicable resolution through civil discourse shall

present their dispute directly to the Black History Brain Bowl sponsor, and if necessary the RHS

Principal to determine an appropriate resolution to the debate.

C. Grievances by individuals or groups affiliated with the Rickards High School Black History Brain

Bowl Team shall present their grievances directly to the team sponsor, who will consult with the RHS Principal or his designee to determine an appropriate response to the grievance; should the

grievance pertain to the sponsor, the individual or group may present their grievance directly to

the RHS principal or his designee.
