Rickards High School Dungeons & Dragons Club Bylaws

Article One: Organizational Status

The Name of the organization is the Rickards Dungeons & Dragons Club (Here after refferred to as the D&D Club).

Article Two: Purpose

The purpose of the Rickards Dungeons & Dragons club is to develop student bonding, social skills, critical thinking, creativity, and mathematical ability by playing Dungeons & Dragons and other similar tabletop role playing games.

Article Three: Officers

Elections

The Dungeons & Dragons club will have four officers who each serve one year terms. They will be elected through a two round election, with each club member without any fines being able to vote via show of hand. If one candidate has 50% or more of the vote they win that election, if not voting progresses to a second round with only the two candidates with the most votes in the first round. Any ties will be resolved through rock-paper-scissors. The officer board will inform all candidate of the specifics of the electoral process one week in advance. The board will elect one of its own to preside over the election, with the remaining officers serving as assistants until the conclusion of the election. The new officer board takes power in the final meeting of the school year in which the entirety of both officer boards are present, or have arranged some alternate communication.

Officer Positions and Responsibilities

President

The president will have any powers not exclusively granted to the other officers and veto power over all decisions made by the officer board. This veto can be overruled by the other three officers voting to overrule. The President will attend to the overseeing and running of monthly meetings. Attends SGA Interclub Councils on behalf of the club.

Vice President

The vice president will preside over meeting planning and ensure proper placement of players within campaigns and the oversight of those campaigns, as well as any duties preformed by the president, should they require assistance. The Vice President runs the club meetings in the absence of the President.

Secretary

The secretary will preside over meetings and will be responsible for setting the agenda, taking notes, running social media pages, and reading the minutes from previous meetings. They are responsible for assisting with the creation of flyers for recruitment.

Treasurer

The treasurer will maintain the club finances, ensuring all dues are paid and monitoring and setting the club budget. Organizes fundraising when possible. These powers are exclusive to the treasurer.

Impeachment and Replacement

If the president is unable to preform the duties of the office, the vice president becomes acting president until the president is able to return to office as deemed by two members of the officer board. The president can declare themselves unable or be declared by a sponsor.

If an officer is not preforming their duties they can be impeached at any time by the remaining officers or sponsor request. The powers and duties of the office revert to the president and vice president until an emergency election can be held.

A sponsor can, at any time, declare a officer unable to perform their duties or impeach them.

Article Four: Qualifications

The club will be open to all Rickards students who have not been expelled from the club previously.

Article Five: Sponsors

The club co-sponsors are Mrs. Dobbs and Mr. Reedy.

Article Six: Dues

There will be a fee consisting of \$5 United States dollars. In case of inability to pay the dues, they will be waived without further inquiry.

Article Seven: Amendments

Any amendment must be approved unanimously by the officer board. The amendment must then be approved by a club sponsor before being written into the bylaws. Sponsors have the right to veto proposals should the proposals not align with the purpose of the club as stated in Article Two.

Article Eight: Meetings

The club will hold General Club Meetings and session meetings.

- I. General Meetings will be held at lunch in Mrs. Dobbs' room (1922) on the first Wednesday of each month.
- II. Group sessions for campaigns will be decided on each year and hosted in one of the sponsor's rooms once a week.
