

## **Girl Flo Club Bylaws**

### **Article I: Name**

The name of the organization shall be Girl Flo.

### **Article II: Mission Statement**

Girl Flo is dedicated to advocating for menstrual equity in education and ending period poverty by raising awareness, providing resources, and fostering a supportive community for students affected by menstrual inequity.

### **Article III: Membership**

#### **1. Eligibility:**

Membership is open to all individuals who support the mission of Girl Flo, regardless of gender and race.

#### **2. Membership Requirements:**

- a. Members must attend at least two meetings per semester.
- b. Members are encouraged to participate in at least one project or event related to the club's mission.

#### **3. Rights and Privileges:**

All members have the right to vote, participate in discussions, and run for leadership positions.

### **Article IV: Leadership Structure**

#### **1. Officers:**

The leadership team of Girl Flo will consist of the following positions:

## 2. **Duties of Officers:**

- a. **President:** Leads meetings, oversees club activities, and serves as the representative of the club.
  - b. **Vice President:** Assists the President and assumes duties in their absence.
  - c. **Secretary:** Keeps minutes of meetings, maintains membership records, and handles correspondence.
  - d. **Treasurer:** Manages club finances, including budgeting and fundraising.
  - e. **Club Sponsor:** To complete and manage all internal and external paperwork in relation to fundraising, field trips, building use and meeting locations.     '
3. **Term Length:** Officers will serve for one academic year. Elections for leadership positions will be held annually in the spring semester.

## **Article V: Meetings**

### 1. **Frequency:**

The club will meet twice a month during the academic year.

### 2. **Quorum:**

A quorum for conducting official business shall consist of at least 50% of active members.

## **Article VI: Committees**

### 1. **Standing Committees:**

- a. **Fundraising Committee:** Responsible for planning fundraising events to support the club's initiatives.
- b. **Advocacy and Outreach Committee:** Focuses on raising awareness about menstrual equity and organizing educational campaigns.

### 2. **Ad-hoc Committees:**

Temporary committees may be formed as needed to address specific projects or issues.

## **Article VII: Finances**

### 1. **Dues:**

No membership dues are required at this time, but voluntary donations are encouraged to support club activities.

### 2. **Fundraising:**
