GROUP BASIC LIFE AND ACCIDENTAL DEATH AND DISMEMBERMENT INSURANCE - ACTIVE MEMBERS

Group Basic Life insurance from Standard Insurance Company helps provide financial protection by promising to pay a benefit in the event of an eligible member's covered death. Basic Accidental Death and Dismemberment (AD&D) insurance may provide an additional amount in the event of a covered death or dismemberment as a result of an accident.

Eligibility	
Definition of a Member	You are a member if you are one of the following: 1. An active board member of Leon County School Board; 2. An active employee of Leon County School Board, other than a substitute, OPS employee, summer school employee and hourly-as-needed teacher, who is regularly working at least 17.5 hours each week You are not a member if you are a temporary or seasonal employee, a full-time member of the armed forces, a leased employee or an independent contractor.
Class Definition	Class 1: Active Members
Eligibility Waiting Period	If you are already a member on the date the group policy is effective, you are eligible on the first day of the month that follows or coincides with issuance of your first paycheck by the Employer. If you become a member after the group policy effective date, you are eligible on the first day of the month that follows or coincides with issuance of your first paycheck by the Employer.

Basic Life Coverage Amount	Your Basic Life coverage amount is \$30,000.	
Basic AD&D Coverage Amount	For a covered accidental loss of life, your Basic AD&D coverage amount is equal to your Basic Life coverage amount. For other covered losses, a percentage of this benefit will be payable.	
Age Reductions	Basic Life and AD&D insurance coverage amounts reduce by 35 percent at age 70 and by 50 percent at age 75.
