

### Students on Regular Pupil Progression

Florida Statute requires that all school districts set expected levels of student performance in reading, mathematics, writing, and science at each grade level. In addition, Leon County Schools has set expected levels of performance in social studies. These levels of performance are used to identify students who may need remediation and students who may be retained. No student may be assigned to a grade level based solely on age or other factors that constitute social promotion or administrative placement [§1008.25(6) (a) Florida Statute ].

### Achievement Codes

Student performance on grade-level work is denoted with an A, B, C, D, or F. Achievement codes are not based on a student's work at his/her own instructional level, but instead reflect the student's performance as outlined by the Florida Standards. The Florida Standards identify the essential skills and knowledge a student needs to succeed academically at each grade level. Satisfactory achievement of the Florida Standards is an indicator of student progress and is represented with grade-level codes.

#### Grade Level/Achievement Codes

<b>A</b>	90% proficiency
<b>B</b>	80% proficiency
<b>C</b>	70% proficiency
<b>D</b>	60% proficiency
<b>F</b>	Less than 60% proficiency

All students are continually monitored for academic progress throughout the school year. Instruction is adjusted accordingly to help students reach their full potential. Students exhibiting a significant deficit in reading must be given intensive reading instruction until the reading deficiency is remediated.

### Minimum Third Grade Promotion Requirement

#### Reading

Students entering 3rd grade in 2014-2015 will be required to achieve a certain score on the 3rd grade English Language Arts (ELA) assessment in order to meet promotion requirements. The score will be determined by the State in the spring. Students not meeting these criteria may still meet promotion requirements through any one of six good cause exemptions [§1008.25(6)(b), Florida Statute].

### Minimum Third Grade Expectations

- Master each Florida Standard at 70% or greater in all core content areas taught.
- Attain a grade equivalent (GE) score of 4.0 GE by year's end on an individualized assessment.
- Read with accuracy and fluency equal to third grade end of year expectations.
- Score at Level 3 or higher on the Florida Standards Mathematics Assessment.
